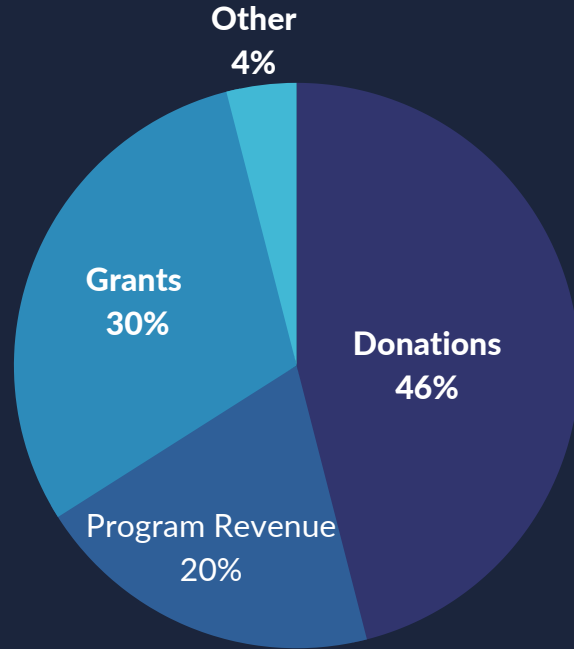

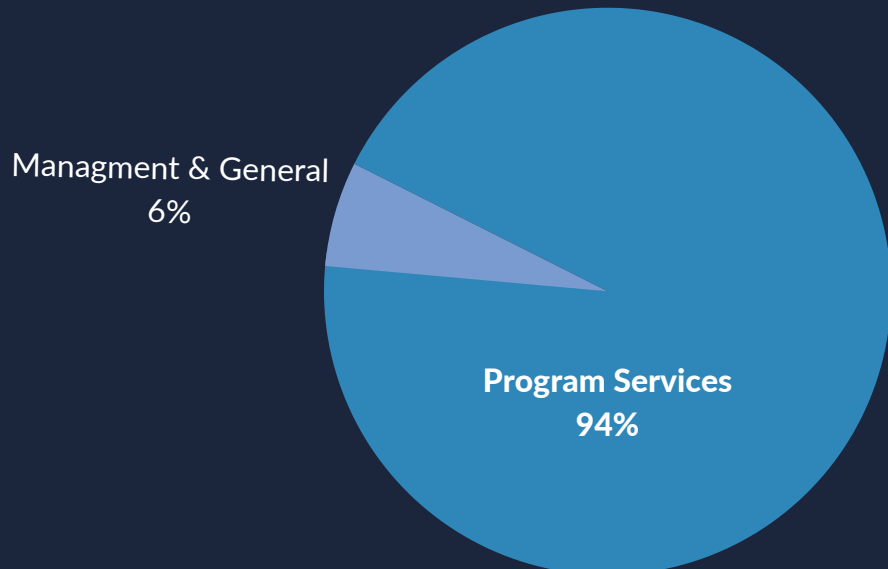

\$478,825

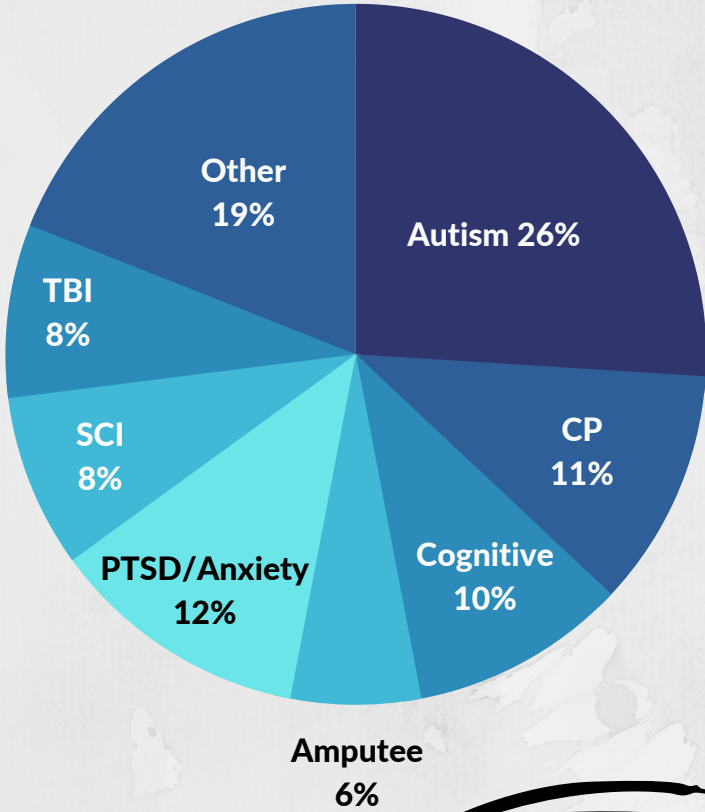


PROGRAM SERVICE EXPENSES

\$315,705

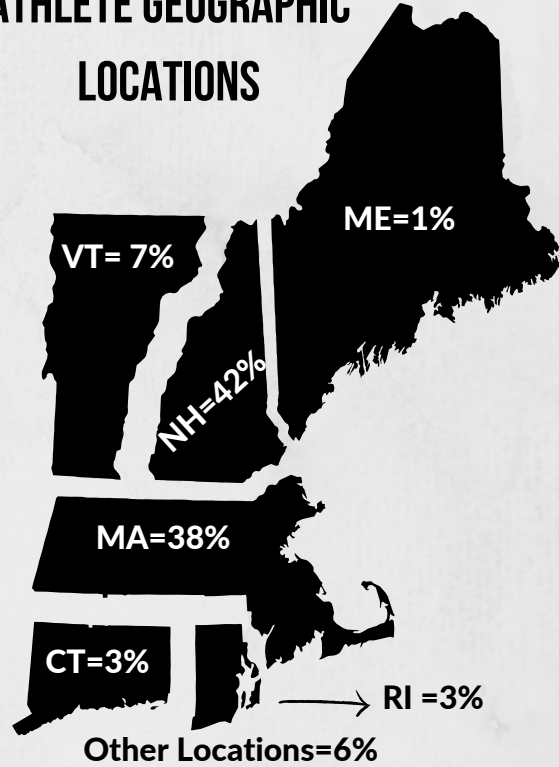

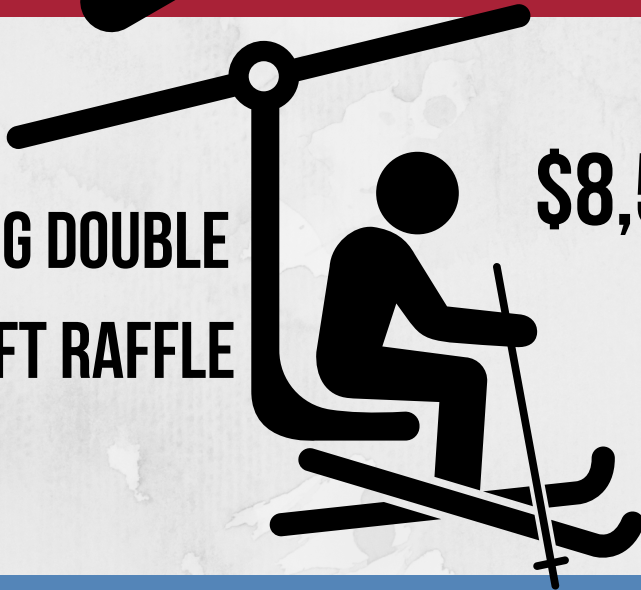
